Tony came by to talk about NCOD to let us know about the confusion and that the fruit loop will be putting on the event which will be October 9<sup>th</sup>, 2010 night and they want to work with HRC on making sure the political side of things are well represented, Tony will get us more information the closer we get to the date and to approach us if they need any help from our royalty and Pride Board itself.

- **Finance-** Check requests- \$177.95 to Jacob M. for the costume making, Nevada Beverage \$2714.00 for an invoice for some reason we did not get, \$208.00 for Matt Cox, \$20.00 for Ernie for costumes, Brian Makes a motion to approve these checks and Justin seconds the motion and the vote is taking and the vote passes.
- **Parade-** Ernie said the parade went well and the layout was perfect, stayed at the festival for 4 hours and handed out follow us cards for twitter, facebook, myspace, also that we need to make sure our feathers for the showgirls and boys say they are fire retardant, there was 106 entries this year for the parade.

- **Vendors** – Jake did meet up with Mona Vie and Theresa Goss to take care of the outstanding vendor deposits.

- **Marketing** – The first Saturday Charlie's/SNAPI event on July 24<sup>th</sup>, 2010, Diane Prince will be co-hosting with Jewdi at this event.

- **Special Events** – Blue Moon 8/7, 9/18- John emailed Ernie about doing a bar Ernie makes a motion to approve this pending the liquor permit being approved and Brian seconds the motion and the vote passes, Ernie makes a motion pending special event approval and Danny G.'s ability Sen. Reid Camp-James said he is throwing a phone banking event at Sen. Reid and asking us to sign on volunteers to make phone calls and will be provide food, Brian makes a motion to approve but put in a disclaimer in the email that says we are not endorsing one particular candidate and Matt seconds the approval, the vote is taking and the vote passes , Interpride Conference (10/21 – 24 \$275 per person, \$179 / night.)- The LVCVA has ask us to put a bid in for Interpride Conference to possibly give good reason to want to possibly give us more money in sponsorship, but in order to do so we need to attend two events, Matt makes a motion we send 4 people and 3 rooms, Justin seconds the motion and the approximate cost is \$3500.00 including both rooms and people, and motion passes.
- **Food & Beverage-** nothing to report.
- **Volunteers-** Volunteer Champions & Committee Certificates – Ernie is going to giving out certificates and requesting a 75.00 budget for this and Ernie wants to hand out a nice plaque for the Outstanding Volunteers for this year's pride events and the plaques are \$17.95 per plaque, the more we buy is cheaper , we are looking to approve up to 20 plaques, Brian makes a motion for \$50 each for the 3 year and 6 year board members, second by Joe for a total about \$600.00.

**New Business** – HRC gala and James wants to make a motion for the 10 people at the table which is \$2750, Brian seconds the motion and the motion passes. Ernie wants to bring up next year's date and he called Dodi and Ester and these dates are open and Jake spoke with Candy is retiring this year and she is training her new placement, James moves to officially change the date and Brian seconds the motion and the motion passes. So now the parade will be held September 16<sup>th</sup> and the 17<sup>th</sup> for festival.
