- HRC proposes to pre-sell tickets
 - o SNAPI will retain \$5 per ticket sold during pre-sell
 - SNAPI will be permitted to hang signage at the entrance to promote membership signup.
 - SNAPI will be partnered for digital marketing, etc.
 - HRC will operate the online ticket sales platform
 - o HRC will market Las Vegas PRIDE dates to their network
 - HRC will host the Annual Silent Holiday Wreath Auction, incurring all costs, and will split proceeds 25% to HRC, 75% to PRIDE
 - HRC will donate back a minimum of \$1,500 and a maximum of \$12,500 back to PRIDE
- Jorge \$5 per EVERY ticket will be required to go back to HRC?
 - o Ron confirms that this is correct ALL tickets sold including the gate at Festival
 - o Ernie can this be ONLY the ONLINE sales?
 - o Ron not in the current draft
