James – review of sponsorship 2017;  James – presents 2017 HRC Sponsorsh  Upon execution of the contract, HRC w	vill provide SNAPI:	

- - \$5,000 via check within 10 days of the contract being signed
  - Forgiveness of 100% past debt
  - HRC will cover all the costs of the tote bags that will be provided when people sign up
  - HRC will provide 2 pop up tents to be used near the main entrance
  - HRC will provide back to SNAPI a rebate according to the scale above, within 10 days after the conclusion of the event
  - HRC will market PRIDE to their database and sell tickets to the festival via the HRC system and provide payment, minus \$5, to SNAPI for each ticket sold, within 10 days of the conclusion of the event

Upon execution of the contract, SNAPI will provide HRC:

- Waive fees for one 10x10 corner booth space with two tables and 4 chairs
- Waive parade entry fee
- Permit HRC to recruit members at 2 booths (that HRC provides) located inside the main entrance to the Festival providing a free gift. SNAPI will provide 2 tables and 4 chairs
- Permit HRC to canvass the festival grounds offering complimentary memberships
- Permit HRC to print PRIDE's logo on the giveaway tote bag
- Submit \$5 for every full sign up that HRC collects at the festival (minus duplicates)
- 3 room nights from 10/20/17 10/23/17 -to be at NY, NY Hotel
