PRIDE

- Blue M asked the Board 5-6 months ago to have an all-inclusive Trans area Blue feels that the TransPride group was not representative of the whole community
 - Requests that the Board holds a community coalition to have a more inclusive area
 James corrects Blue that TrasPride group (clarifies that they are a separate group to Las Vegas
 PRIDE) was offered a sponsored area they requested not to work with Blue;
- Kelly Inquires about how scripts are submitted for the Parade;
 - James explains the relationship between COX and SNAPI; the selection of stage hosts; submission of scripts etc.
 - Kelly asserts that she feels that hosts on the stage of the Parade made purposefully hurtful statements about the Trans community
 - \circ $\,$ James inquires what can we do to make up improvements; Kelly requested more time to answer

Alexandria – addresses the Board with a prepared statement; requests that the Trans community have a representative on the Board of Directors

James – shares with the community that we are a non-profit group, all volunteer, giving hundreds of hours back to the community – and that we have worked under financial strain to produce the annual events etc. – we do the very best we can

- James shares that our hosts had no ill intent; James acknowledges that we took responsibility and are taking all steps we can to make improvements
- James shares how our Board is structured and the process by which individuals can get involved; asks for community involvement;
- Yoshi inquires as to how PRIDE can make amends to the community and be more inclusive
 - Clair explains how TransPride came to exist as it is today; their group wants to exist on their own – they partnered with The Center but that relationship has ended; we have continually invited and asked for involvement – as much as we want to have less division, we cannot override the wishes expressed to us by other community groups
- Zoe shares a prepared written statement;
- Alethia shares a prepared written statement by herself and Lea H; shares her disappointment in the event and the Board
- Katarina shares her experiences and disappointment in the organization;
 - Requests a public apology to the Trans Group; James thanks Katarina for giving specific requests and commits to follow up
- AJ wishes to address the parade and the community; requests more visibility
- Danielle expresses that she feels that the Board is not approachable and is not representative of the community
 - Expresses that the Board needs diverse representation on the voting Board; shares that she does not want to be a part of that group
- Ashley agrees with Danielle; expresses that their 3 million dollar business does not want to be a part of our group
- Steven interested in bringing diverse representation to the Festival by adding an adult only area; Mike – shares that the Board has welcomed him and his help and involvement; shares that instead of pointing out faults, please give a chance
 - Brady motions to approve a statement on behalf of the Board to apologize to the Trans Community for stage statements that were made at the Parade; Jorge 2nds; motion passes unanimously
